ORDINANCE No. 2217

AN ORDINANCE AMENDING THE ZONING REGULATIONS OF THE CITY OF AUGUSTA, KANSAS, 2020, BY AMENDING ARTICLE 10.40(a) AND REPEALING ANY PROVISIONS OF SUCH ZONING REGULATIONS OR OTHER ORDINANCES OF SAID CITY IN CONFLICT WITH AMENDED SECTIONS.

**WHEREAS**, the Augusta City Council adopted the Augusta Action Zoning Regulations via Ordinance No. 2170 on October 19, 2020; and

**WHEREAS** the Augusta City Council adopted the first amendment to the Augusta Action Zoning Regulations via Ordinance No. 2182 on November 15, 2021; and

**WHEREAS** the Augusta Planning Commission authorized Planning and Zoning staff to pursue text amendments to the adopted zoning regulations on November 28, 2022; and

**WHEREAS** the Augusta Planning Commission conducted a public hearing on February 27, 2023, to take input on the proposed zoning amendments pursuant to K.S.A. 12-747, where the Augusta Planning Commission voted to recommend approval to the Augusta City Council.

**NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF AUGUSTA, KANSAS:**

**SECTION 1:** Amendments. The following sections of the zoning regulations shall be amended as follows:

**Article 10.40 “Tattoo or Body Piercing Studio”**

- C. Tattoo or Body Piercing Studio shall be permitted by-right in the C-1; C-2; C-3; and M-1 zoning districts only.

**Article 5.3 “Table of Primary Uses by Zoning District”**

- 5.3 Remove ‘Tattoo or Body Piercing Studio’ from *Arts & Culture Uses* category.  
Replace ‘Tattoo or Body Piercing Studio’ to *Personal Care Services* category.

**SECTION 2:** Repeal. All provisions of the zoning regulations and other ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.

**SECTION 3:** Effective Date. This ordinance shall be in full force and effect from and after its publication in the official City newspaper.

PASSED, ADOPTED AND APPROVED by the governing body of the City of Augusta, Kansas, this 20<sup>th</sup> day of March 2023.


